4. FIRST AID MEASURES

5. FIRE FIGHTING MEASURES

Handling:

Keep in a cool, well ventilated area. Do not puncture, incinerate, or expose to temperatures above 48.9 °C (120 °F). Heat from sunlight, radiators, stoves, hot water, and other heat sources could cause container to burst.
